This is a capital campaign and there is no guarantee EBC will reach its goal of raising \$1,750,000CDN to purchase the Project lands. EBC presently has until May 5, 2021 to waive the financing condition on its offer of purchase, which date may be extended at the option of the buyer and seller of the Project lands, without notice to you. EBC will rely on this pledge when deciding whether to waive the financing condition. As such, **this pledge cannot be withdrawn by you once conditions are waived**. Once conditions are waived, EBC shall be permitted to redeem this pledges required in order to meet its obligations on or before closing. In the event of a surplus of funds raised, EBC will be permitted to apply your gift to a separate fund to steward the Project, or to EBC's general fund. While EBC will endeavour to notify you of extensions and the waiver of conditions, its volunteer staff cannot commit to do so. EBC shall not be permitted to redeem this pledge if EBC is unable to close the purchase of the Project lands, in accordance with its accepted offer.
